SECTION 2: Hazard(s) Identification

2.1 Classification of the substance or mixture (GHS Classification)

- Acute toxicity, Oral (Category 4), H302
- Skin irritation (Category 2), H315
- Serious eye irritation (Category 2A), H319
- Specific target organ toxicity - single exposure (Category 3), Respiratory system, H335

2.2 GHS Label Elements

Signal Word: Warning

Hazard Statements:
